Chaperones must be at least 18 years of age. More than one child can attend, but only one parent or chaperone per child. The weekends are open to girls 6-15 years of age.

Registration Process:

All camp registration/waiver forms and fees are to be completed and paid online at least two weeks prior to the start of the program. If trying to register after the deadline, a \$15 late fee will automatically be added to your registration fee. It is understood and agreed that no refund or reduction in fees are made for late arrivals, early departures, withdrawal or requests to leave due to misconduct. Once the session fills up a waiting list will be started online. Names will be added in the order in which applications are received.

How to Register:

Online: www.laparks.org/camp/camp-hollywoodland Complete online registration process and submit online payment. *For a smoother registration process, check that all participants being registered are listed in your household before beginning the registration process. Both the parent/guardian and child must be registered in order to attend our program.

Registration is accepted and processed on a first-come, first-served basis. The rules of acceptance and participation in camp programs are the same for everyone, without regards to race, color, religion or national origin. Persons with disabilities are welcome to participate in our programs. Reasonable accommodations will be made with prior notification. Please allow a minimum of 2 weeks prior notification for interpretive services.

Cancellation & Refund Policy:

All cancellations must be in writing. Telephone calls must be followed up with a written request for refund. Refunds may take up to 6-8 weeks after the request is received in writing. Registration fees will be refunded as follows: less \$10 per person with two weeks or more notice; less \$25 per person with less than two weeks notice. There are NO REFUNDS for FAILURE TO SHOW.

Supervision

Children must be accompanied and supervised at all times by their parent/chaperone. Camp Hollywoodland staff is responsible for preparing and leading activities; they will not be available to supervise children. Unaccompanied children will be returned to their parent/chaperone immediately. Proper authorities will be contacted if the adult refuses to accompany their child.

Health Protocols

Camp Hollywoodland follows the Department of Recreation and Parks guidelines and procedures regarding COVID-19.

Vaccinations: Recommended for all participants. <u>Required</u> for program participants 12 years and older. Masks will be required when handling food and visiting communal food areas within the dining hall.

Health Check: Every participant will go through a basic health check, which will include a series of wellness questions and a head to toe evaluation.
