





Yes, a huge thank you Officer Contreras. Your involvement with our community has made all the difference these past years. When the community is heard and engaged, it helps so much for the residents of this SECZ area to actually live here. While the comprehensive clean-ups are necessary, and really the only action the city is willing to take, our small community is constantly and graphically reminded of how ineffective this strategy has unfortunately been. Every Thursday, we watch the same show: people piling back out of cars and vans, or coming out behind the banyan trees. and setting back up 5 minutes after the cleaning crews and city agents leave. Every week, we witness drug use, litter, half-naked people (at times fully nude), tent explosions, car explosions, overdoses...all within hours/days of the clean-ups. It has been over 2 years now, and one has to wonder: who is this helping? While the long-term strategy of assisting the unhoused at any cost plays out in a 10-years trajectory(if we are lucky), how are the people involved faring? Are the 500 children that go in and out of Westminster Elementary and other early education facilities in the immediate vicinities being helped by this strategy? How?

We WANT tents down at 6 AM starting now. We NEED this area to be designated as a sensitive-site now.

I don't want to have to walk my kids past this encampment to go to school any longer-it's fundamentally wrong. This district needs to start doing what's right for the mental health of its most vulnerable and impressionable citizens...otherwise the cycle continues.

#### Honorable RAP Commissioners:

The Neighborhood Council of Westchester / Playa (NCWP) strongly opposes the granting of a permit for Safe Parking in Westchester Park. Our constituents stand in opposition as well. We have received hundreds of letters from our constituents opposing Safe Parking in Westchester Park, and we receive complaints from constituents about the Safe Parking program nearly every day. We ask that you deny the permit request for the following reasons:

The Chief Administrative Officer, in his report of August 10, 2021, determined Westchester Park is not feasible for Safe Parking because it is used by thousands of people. Westchester Park is the only park in Westchester, which has over 40,000 residents. The park also serves many people from Inglewood and other inland communities, who use and enjoy all park facilities and recreation programs. Westchester Park is one of equity and inclusion. The City of Los Angeles is "park poor", meaning there is a shortage of park space.

The Safe Parking program near the recreation pool and ballfields uses 25 of the 50 parking spaces in that lot. Yet the fenced in Safe Parking area is nearly empty many nights, and has at most 10 cars using the fenced in lot. Vehicle dwellers who do not want to follow the rules of Safe Parking program live in their vehicles outside the fenced Safe Parking area in the same parking lot. Between Safe Parking (25 spaces) and vehicle dwellers in that lot (8 spaces), there are only about 17 parking spaces available for pool users. Later this summer, the ballfields will be open as well, and there will be a critical need for parking spaces in the park.

Just in the last two weeks, a homeless man went on to the tennis courts in the park saying the 12-year-old girls who were taking lessons on the court wanted to have sex with him. The next day, he jumped a fence onto another court where young girls were taking lessons, and talked about having sex. A homeless woman grabbed a clipboard of an elderly woman at the courts and yelled and screamed at her. Over the past couple years, there have been hundreds of incidents of homeless people indecently exposing themselves to children, harassing and attacking children in the restrooms, following children, using IV drugs in public, and more.

The safety of children and seniors is of utmost concern to the NCWP and to our community. We believe that having homeless interventions in our public park is inconsistent with public safety and poses a risk to park users. Westchester Park is the only park in the City with a Safe Parking program.

The NCWP does not oppose Safe Parking programs in general. However, we strongly oppose the use of any parking lot in Westchester Park for a Safe Parking program because it uses precious parking spaces, and it attracts homeless people who live in the park full time.

LAX will have 50 spaces of Safe Parking beginning this summer, approximately two miles from Westchester Park. The eight or so vehicle dwellers who use the Safe Parking at the park may park at LAX Safe Parking instead. We respectfully ask that you deny the permit request for Safe Parking. We ask this as compassionate elected stakeholders for the whole community and authorize the President to take the appropriate action to promote this position.

I was on the call yesterday, but didn't get the chance to formally respond on the call. That being said, I wanted to voice my opinion/concerns to you.

When I review your mission statement, it appears you desire to provide a "...attractive, safe and well-maintained parks with diverse opportunities to serve and enrich every community." That is an excellent goal.

However, my concerns are with the potential approval of the "safe parking" effort in Westchester Park. While I support the concept, I have the following concerns as related to Westchester Park:

- 1. Westchester Park is exactly that, a park for all to enjoy, both for the resource and the "availability to access it". Its original design was only that and the limited associated parking was to allow that. When the "safe parking" was first approved by the Neighborhood Council Westchester/Playa (NCWP) it was contained in the councilman's lot and had no impact to the parking lot footprint approved for the operation.
- 2. At some point in time, that was expanded to include "park managed property", with park users losing 50 spots for usage during the daytime (lot secured during the day) Understanding this came at the onset of Covid19, some latitude was applied to assist with the pandemic.
- 3. Since that time, the park has been cleared of all the homeless encampment and major renovations have occurred (pool upgraded and opened and ball fields redone for multiple usages - baseball, soccer and football to name a few). With those improvements, it is highly anticipated the utilization of "our" park will dramatically increase and return to the vibrant recreational area we so desperately need.

So why is there so much apprehension to a effort such as "safe parking"?

Simply put: it is an excellent concept, BUT is not conducive to a "park environment". We have so little space for people to enjoy recreational activities, so why take that away for a process that can be accomplished in many other locations than that of a park's parking lot.

Couple that with the fact that the assigned location has been highly underutilized since its migration to the park managed lot AND that there is LAWA approved 50 slots on property outside of a park, why would the RAP Commissioners see this as "in line" with their Mission Statement?

Finally, the only other parking opportunity, available to park goes, is a "municipal lot", NOT controlled by RAP, and as you can see is completely mismanaged by CD11 and the city of Los Angeles and if CD11 leadership (Mr. Bonin) gets his way, he will acquire 50 more slots there for more "safe parking" and you will be committed to a lease that takes away critical parking for the park with no recourse.

I hope this does not fall on deaf or prior committed ears and you truly weigh all the factors here and the potential impact to Westchester Park, that you are spending tons on money for our community.

I am on the NCWP, but this represents ONLY my personal viewpoint, however, I do believe it represents much of the community as a whole. I have live and raised my my family here for over 34 years and have utilized the park extensively and would love to see that to continue for young families for years to come!

Our youth and their families cannot safely park across Lincoln (Hwy 1) or Manchester (a main artery) to access the park.

I include the photos below which I took over the past several months showing that the Safe Parking program in Westchester Park is not well used. Most nights, only a fraction of the spaces are used. I took these photos because I was informed by Sonya Young-Jimenez that Safe Park LA told me that the Safe Parking program in the park was successful and well used. That was not consistent with the observations of our community members who drive by the park at all hours while driving people to the airport, etc.

I would not dispute that people are enrolled in that program and that the City is paying for their use of the program, but they are not using it. The program is inefficient and it uses the much needed parking of park users. Those 25 parking spots are fenced all day, and no one else can use them.

We have a 50-space Safe Parking program opening at LAX this summer, just a mile or two away from the Westchester Park site.

Please do not allow the City to take parking from park users who need it. The safety of our youth, from all communities, using the ballfields and the recreation pool depends on the availability of these parking spaces.







Report on Hollywoodland and the 4th of July weekend 2022

Yesterday July 2

The View Site

At approximately 3:30 I drove by and saw a crowded view site with illegally, uncited cars. I saw no DOT at the top. I spoke with DOT at Lake Hollywood Drive and Tahoe who said no one would be stationed there, but would be traveling. I said someone needs to be stationed there (as was in CD4's plans) and he said he would speak to supervisor.

At approximately 5:30 I returned to this area coming from the Barham side. DOT was stationed at Lake Hollywood Drive and Tahoe. I passed him and about 20 cars up I was stopped

in a total traffic jam. It involved both sides of the street. Cars were at a complete stop for over 5 minutes!! I filmed most of it. There were approximately 100 cars at the view site with 15 involved in waiting for parking spaces or trying to get into parking spaces. This is one of the main arteries for ingress and egress into our neighborhood. It would have been impossible for an emergency vehicle to get through. I wish I could say this is a unique experience, but it is the opposite and happens often. This bootlegged illegal magnet (put in with no process) is out of control and dangerous. The other DOT person was at the top at this time, and the problems were between the two of them. The crowds are huge and maybe a minimum of 4 City employees need to be there. (This still leaves the immediate surrounding areas uncovered that also need supervision. 1) where pedestrians keep walking between the no pedestrian signs 2 The ever growing number of people using Innsdale Drive a removed street as a trail in an animal habitat filled with dry brush that is a tinder box.) This vista site location is so problematic it never would have gotten approval if a proper City process and review had occurred.

What is the capacity of this area? Indoor public places always have a capacity set by the fire department. Other outdoor areas of Griffith Park are shut down when they are "over capacity".

This area has the least infrastructure--can you imagine the gridlock of 100 additional cars on our extremely narrow, substandard streets in the midst of an emergency evacuation--yet it is never shut down.

Why is this? At the very least a safe capacity must be set and enforced for this area.

Again we are requesting that you limit access to all of Hollywoodland over this holiday, and if not--at least close down this magnet. It is a danger to the entire neighborhood.

AT THIS POINT WE ARE DEMANDING THAT YOU LIMIT ACCESS TO ALL OF HOLLYWOODLAND FOR THE REMAINDER OF THE HOLIDAY.

Yesterday July 3

#### Ledgewood

At 3:15 an oversize illegal camper (over our weight limits) trying to turn around blocks traffic from four different directions for 15 minutes causing a line of 28 cars just on Ledgewood, and backing on to Beachwood!

#### Mulholland

A group of 30 dirt bikes tries to go unto dirt Mulholland, but DOT prevents them. They then take Heather to Durand to Canyon Lake Drive. Because of their numbers they are noisy, run through a stop sign, and take over the width of the street almost causing a car accident. DOT says it has been very busy with their preventing many vehicles from going past the sawhorses. DOT says the large amount of traffic is made worse and more dangerous there because **DWP has** been doing a major project on Mulholland for months and the barricades in place there reduce the already limited capacity of the streets.

#### The Vista

At around 5:30 it is full and I see at least 12 illegally parked cars--none of which have been cited. I speak with the DOT person at the top. He thought another DOT person at the bottom would be taking care of it. He says he will call his supervisor.

#### Deronda

I see at least 5 illegally parked cars that are not cited.

### Rockliff

I speak to the DOT person there. He says he has prevented cars from going up the last leg of Deronda and it has been very quiet. He says that now it is past 6pm and many of the PPD rules expire it is getting very busy with people coming and parking. He can see illegally parked cars but says he is not allowed to cite them! He is only allowed to deal with the intersection at Deronda and Rockliff. Starting at that intersection I count 16 illegally parked cars none of which have been cited! There are so many cars that it is hindering the flow of two way traffic. I see a DOT person on Ledgewood and tell her about the illegally parked cars and their locations. She is totally unfamiliar with our streets, but says she will try to help. (Accounts from other residents complain the illegal parking goes on for hours there with no enforcement.)

I will try to clarify the situation in Hollywoodland once again. EVERY PARKED CAR PREVENTS TWO WAY TRAFFIC because our streets are so narrow. Our one hundred year old substandard infrastructure barely handles the needs of residents. While there are parking places in the street they are to be sparsely used. If many or every street parking place is occupied,

two way traffic is impossible. We do not have the capacity to be a tourist destination. That is why we have ppd's. They mainly only go until 6 pm. In the summer that is inadequate.

We are in a vhfsz, 80% surrounded with dry brush and clear traffic circulation is a matter of life and death.

Over the past few days you have had officers in our neighborhood. Time and again it has failed to adequately meet the challenges here. (These incidents are mainly examples

from a one time a day random drive around. There are certainly many other incidents during the day that are not included.) While we prefer prevention, you have not even managed to cite large amounts of illegal activity,( and in fact towing instead of a ticket would be a much more appropriate and safe alternative.) Even the Hollywood Sign was illuminated! In the end we do not have the capacity for large vehicles that get stuck or the number of cars that gridlock our streets and need parking that is dangerous when offered.

AGAIN WE ARE NOW DEMANDING THAT YOU LIMIT ACCESS TO ALL OF HOLLYWOODLAND FOR THE DURATION OF THE HOLIDAY. SO FAR YOU HAVE NOT ACHIEVED YOUR GOALS. YOUR PLAN IS NOT WORKING. WITH CLOSURE YOU WILL USE FEWER RESOURCES WHILE ACHIEVING MUCH GREATER SAFETY. IT IS DANGEROUS HERE. CONDITIONS ARE UNACCEPTABLE. YOUR WORKERS CAN ATTEST TO THIS. JUST CLOSE DOWN OUR AREA IN THE NAME OF PUBLIC SAFETY AS OTHER PARTS OF THE PARK AND OTHER STREETS ALL OVER THE CITY ARE CLOSED EVERY DAY.

I am writing to you in my capacity as president of the board of directors of Grand Hope Park, Inc., the non-profit organization that leases Grand Hope Park, located at 919 South Grand Avenue, in the Southpark district of Downtown Los Angeles, to request a modification of the park's operating hours.

Presently, the park is open to the public until 8:00pm during Daylight Savings Time, and 6:00pm during Pacific Standard Time. I wish to lodge a complaint against the tenant at the Penmar Golf Course. I live opposite the course and every Wednesday night we are forced to endure a live music event that considerably exceeds the legal limit. Even with all our windows and doors closed the music is loud and clear. I have weekly video evidence of the violations taken with a decibel meter that have been shared with the LAPD and the ABC, both of whom have open investigations into the Penmar's conduct. The LAPD is aware of the issue with the noise because The Penmar does not have a permit to play live music. The Penmar have been issued a cease and desist from the LAPD but have ignored it. They have also been cited by the ABC but ignored that citation too.

The code on noise is abundantly clear:

SEC. 112.01. RADIOS, TELEVISION SETS, AND SIMILAR DEVICES. (Amennded by Ord. No. 156,363, Eff. 3/29/82.)

- (a) It shall be unlawful for any person within any zone of the City to use or operate any radio, musical instrument, phonograph, television receiver, or other machine or device for the producing, reproducing or amplification of the human voice, music, or any other sound, in such a manner, as to disturb the peace, quiet, and comfort of neighbor occupants or any reasonable person residing or working in the area.
- (b) Any noise level caused by such use or operation which is audible to the human ear at a distance in excess of 150 feet from the property line of the noise source, within any residential zone of the City or within 500 feet thereof, shall be a violation of the provisions of this section.
- (c) Any noise level caused by such use or operation which exceeds the ambient noise level on the premises of any other occupied property, or if a condominium, apartment house, duplex, or attached business, within any adjoining unit, by more than five (5) decibels shall be a violation of the provisions of this section.

I live considerably further than 150 feet from the property line and still the noise is excessive. The residents in our area, and there are many of us, are fed up. We have been trying to draw your attention to this issue for many months and left multiple telephone messages that have gone unanswered. We request that the Commissions Task Force on Concessions include this issue on the agenda of their next board meeting, which we're told are held on the third Thursday of every month. Several of us would like the opportunity to put forth our complaints.

The Penmar can take physical steps to mitigate the noise, but they consistently choose not to.

I have been told to contact you regarding the new "Hollywood Bowl" at the Penmar.

The Penmar can take physical steps to mitigate the noise, but they consistently choose not to. Even the actual Hollywood Bowl makes considerably more effort to mitigate the noise and they are not in a residential area.

We live up the hill from what used to just be a golf course. We chose to move here so we could enjoy the great green space and enjoy the peace and quiet.

I am so shocked that they were issued a permit without evaluating the impact on the residents.

Our Wednesday evenings are now spent locked in our house and even with the TV up loud we can still here the music and the shrill yelling of "come on everyone make some noise"

We have been recording the decibel readings and without fail every week they exceed the noise ordinances.

The LAPD have calls weekly from residents complaining about the ongoing noise issues. Who have issued a cease and desist letter and are being ignored.

The ABC have also cited them and are also being ignored.

I'd like to remind you of the legally established code on noise:

SEC. 112.01. RADIOS, TELEVISION SETS, AND SIMILAR DEVICES. (Amennded by Ord. No. 156,363, Eff. 3/29/82.)

- (a) It shall be unlawful for any person within any zone of the City to use or operate any radio, musical instrument, phonograph, television receiver, or other machine or device for the producing, reproducing or amplification of the human voice, music, or any other sound, in such a manner, as to disturb the peace, quiet, and comfort of neighbor occupants or any reasonable person residing or working in the area.
- (b) Any noise level caused by such use or operation which is audible to the human ear at a distance in excess of 150 feet from the property line of the noise source, within any residential zone of the City or within 500 feet thereof, shall be a violation of the provisions of this section.
- (c) Any noise level caused by such use or operation which exceeds the ambient noise level on the premises of any other occupied property, or if a condominium, apartment house, duplex, or attached business, within any adjoining unit, by more than five (5) decibels shall be a violation of the provisions of this section.

I'd like to request that the Commissions Task Force on Concessions include this issue on the agenda of their next board meeting.

We have been told the only way to actually stop this is by suing all the parties involved. This would be time and consuming and very costly for all involved, but we are strongly considering this option and will be following this course of action if The Penmar (your tenant) chooses not to modify their behavior.

Good afternoon, Tom,

Of the 400+ parks throughout Los Angeles, there are about 150+ LA City parks and recreation centers that are located within the Metro region. As you know, since being reassigned to the Metro region in January 2022, my partner Ranger Fuentes and I have been very responsive to all the complaints we have received from different members of the Debs/Arroyo Seco community. Unfortunately, over time as we received more and more complaints from the other parks and recreation centers throughout the Metro region, we found ourselves travelling to different parks scattered over a wide area. We still don't know the outermost boundaries of the Metro region, but we have responded as far west as Poinsettia Rec, as far northeast as Eagle Rock Rec, down to Evergreen Rec to the southeast, and down to MacArthur Park to the southwest. My partner Fuentes and I are the only two Rangers assigned to the Metro region under our sergeant, Senior Ranger J. Pineda #1522. Therefore, I understand that it may appear as though we have neglected our patrols of Debs, but in truth we're simply trying our best to serve the Metro region as a whole. That could mean addressing a wide array of complaints: homeless encampments in and around Rec buildings or in VHFHSZ areas, transients threatening or assaulting staff or interrupting park programs, vandalism of park property, simple leash law violations, narco activity, brush fires, and much more. Sometimes we have community events to attend such as Kids to Park Day at MacArthur Park or the Lotus Festival at Echo Park. Other times we're stuck providing support to major events such as Summit of the Americas or 4th of July in Elysian Park. Last week we were stuck at Elysian addressing the problem of people feeding coyotes in the area of Northeast Little League Fields which resulted in a 1-1/2 year-old girl getting rushed to White Memorial Hospital after getting attacked by a coyote. The next 2 days after that we had to escort California Fish & Wildlife and a trapper from USDA as they set up traps and exterminated coyotes in the area - it wasn't pretty. My point is, overall, we just have to be available to all the communities of the Metro region. That's not to say we don't put a high priority on Debs. The more active and vocal the community is, the more Fuentes and I tend to focus on them.

Now, the last report Fuentes and I received about Debs park had to do with new encampments. So far, we were only able to locate and remove 1 of them. I asked Pae if she could provide us with more information on locating those other encampments once you guys got back from vacation. I believe you were included in that email, Tom. If you have any specific information such as GPS coordinates or What3Words, even a general idea of which trail and perhaps its distance from a trailhead or other landmark, it would be very helpful.

Although some issues we have addressed in the past are still ongoing, the only complaint we have deliberately not addressed so far is the report of alleged drug dealing from the silver Mercedes Pae sent pictures of. We haven't

observed the violations yet, but according to Bill, there was some recent history of LAPD making contact with individuals engaged in narco activity along Griffin Avenue and at least 1 firearm was found during the arrest. It makes sense to us that those engaged in narco activity have a high probability of carrying a firearm as they would otherwise make good robbery targets by other criminal elements in the area. As a result, Fuentes and I chose not to put ourselves in that situation as the community already knows, we are conducting law enforcement duties unarmed. We simply have no reasonable defense against someone with a firearm and we have expressed this before to the community.

You mentioned prostitution activity. This is the first time Fuentes and I have heard of this. If you can provide us with more information on what you observed and where, we will look into it.

As far as RVs along Griffin, we are still waiting to hear back from a City attorney regarding the impounding of vehicles being used as active dwellings.

Sandy recently emailed us some information regarding the Bridewell Armory. We plan to visit the site this week to see if we can speak to someone directly about whether or not it's an available option.

We'll continue patrolling Debs Park in addition to addressing issues from some of the other parks we have received complaints from, but I want to make it clear that Fuentes and I have always appreciated how active the Debs community has been when it comes to reporting issues throughout the area. Please continue to do so and we can assure you that we're listening, we take all your reports into consideration, and we try to handle them as best we can.

We came upon a smoldering fire inside Debs Park this morning. Fortunately, the Fire Department was already there, having been summoned to log on fire closer to Griffin Avenue, then came upon this one by accident. There was a person nearby that seemed suspicious enough that the lead Firefighter threatened to call the police to arrest him for setting both fires.

My question is, why are things getting worse again? Griffin had been cleared of much of the RV parking as well as satellite drug/prostitution activity, but now all that's coming back. And pyromaniacal meth-crazed people have returned to living in the park.

What can we expect the Councilperson to accomplish here before he leaves office? Will he build the fence he promised for the park? Will he put pressure on the Rangers to spend more time here to enforce the laws? Or will we have to wait for another disaster before anything gets done here?
